- A directly negotiated award may not be challenged (*13 CFR 124.517(a)*).



SDB AND NATIVE CREDITS

- Federal agencies contracting to an 8(a) Tribal entity may claim SDB and Native American credits. (*13 VFR 124.1001 and 13 CFR 124.109*).
